RE: Phragmite Removal Update, 932 Craigville Beach Road & 39 Prospect Street, Centerville, MA (DEP File #SE3-5763)

Dear Ms. Karle & Members of the Conservation Commission:

On behalf of the Red Lily Pond Project Association (RLPPA), Environmental Consulting & Restoration, LLC (ECR) is pleased to provide this update regarding the work to remove Common Reed (*Phragmite spp.*) at 932 Craigville Beach Road & 39 Prospect Street in Centerville (the site). The work to remove Common Reed at the site has been undertaken by the RLPPA and has been completed in accordance with the Order of Conditions, DEP file #SE3-5763.

Most recently, RLPPA completed the removal of Common Reed between August 21-23, 2023. Work was completed between the "40 steps" at the eastern end of the site and the footpath that is an extension of Prospect Avenue at the western end of the site. The majority of the work was contained to the herring run and the banks/upland immediately abutting the run. In accordance with the approved methodology, all work was completed by hand using shears to cut the Common Reed near the base, which was then immediately collected and placed in trash bags and disposed of at the local transfer station to be incinerated. ECR was onsite to observe the protocol and Conservation and Natural Resources were both notified prior to the commencement of work.

At this time, work to remove Common Reed at the site by the RLPPA has been completed. It is expected that no other work will be completed until next year. Prior to the next round of removal, the Conservation Commission and Natural Resource Department will be notified.
